

AMENDED DEDICATION AND RESTRICTIVE COVENANTS

BE IT KNOWN that on this 8th day of April, 1999, before me, Notary, the undersigned authority, a Notary Public in and for the Parish of Evangeline, State of Louisiana, and in the presence of the witnesses hereinafter named and undersigned, personally came and appeared:

DROUET W. VIDRINE, married to and living with Jacqueline Olivier, a resident of Evangeline Parish, Louisiana, after being duly sworn did state that:

On or about December 29, 1959, before Jean W. Pucheu, Notary Public, "Dedication and Restrictive Covenants" of the subdivision known as "de Monchervaux Subdivision" were created and filed in the records of the Evangeline Parish Clerk of Court's Office in Conveyance Book B-154, at page 518 and bearing Original Act No. 192757.

In the list of properties included in said act eight (8) certain lots in the Estate of Ernest Etienne Ortego Subdivision which were completely separate and distinct from the land intended to be included in said subdivision were inadvertently included and which lots were described as follows, to wit:

Eight (8) certain lots or parcels of ground located in the Estate of Ernest Etienne Ortego Subdivision of Evangeline Parish, Louisiana, described as Lots 32, 33, 34, 35, 36, 37, 38, and 40 of Plat C of said subdivision, all as will more fully appear by reference to Plat of Survey and subdivision and part of the property in the Estate of Ernest Etienne Ortego made by Tate and Latour, Surveyors, dated August 29, 1951 and duly recorded in Plat Book 2 at page 119, Records of Evangeline Parish, Louisiana.

It was never the intent of appearer, DROUET W. VIDRINE, to include said lots in said subdivision, the same being separated from the main body of the subdivision by both a drainage canal and a road now known as Humana Road.

By this Act, appearer does hereby amend said Dedication and Restrictive Covenants to delete and remove said lots from the restrictions set forth in the

original Dedication and Restrictive Covenants of the "de Monchervaux  
Subdivision".

Appearer does hereby direct the Clerk of Court for Evangeline Parish to note  
this amendment to said Dedication and Restrictive Covenants indicating this Act of  
Correction for it was never his intent to include said lots in the Dedication and  
Restrictive Covenants, the lots being separate and distinct from the main body of  
the subdivision.
